### II. Meeting Summary

# Welcome, Meeting Objectives, and Agenda Review

Monitoring work group chair Dr. John Balbus, NIEHS, welcomed members to the final work group call. Kathy Grant, RESOLVE, took roll and reviewed the call objectives.

Balbus noted that the current version of the work group report reflects the leadership team's efforts to address the pertinent feedback received during the comment period (i.e., feedback from <u>the public</u>, the *National Conversation* Leadership Council, and NIOSH), and any additional changes to the report will have to meet a high threshold to warrant consideration at this late stage.

Balbus said that the work group report has been generally well received by the public and the *National Conversation* Leadership Council. Balbus then raised the issue of federal participation in the process, noting that he and other federal employees will need to resolve the tension

between the process' call for specific, actionable recommendations and the role of one federal employee participating in a project that ultimately calls on another agency to implement recommendations. Grant reminded Balbus and the work group that the process is structured so that RESOLVE is the convening organization. She confirmed that the project is not a Federal Advisory Committee under FACA. Balbus said that federal agency representatives will need to determine whether the process works for them, and whether language will need to be qualified so as to be less directive.

# **Discussion of Proposed Changes to Sections I-III**

Balbus led the work group through a page-by-page discussion of the edits and outstanding issues in the report. Members accepted the leadership team's proposed edits to address children's environmental health and occupational health. In addition, the following additional decisions were made on the call:

## Page Decision approved by members present

- 3 Edited "Exposure Levels Subgroup" description to clarify that the subgroup focused on markers of exposure in fluids or tissues of human beings
- 3 Edited description of health surveillance to be more comprehensive
- 6 Replaced "food additives" with "substances in food"
- 7 Spelled out "STORET" as Storage and Retrieval Data Warehouse
- 9 Removed "Thus" from first paragraph of "Strengths and Limitations of Environmental Monitoring" section (to suggest that the supporting information follows and does not come before this sentence)
- 11 Replaced Confidential Information Protection and Statistical Efficiency Act §108 with Consumer Product Safety Improvement Act §108
- 12 Added soil surrounding the home as a source of lead paint exposure in the "Strengths and Limitations of Biomonitoring" section
- 15 Added paragraph on national poison data system
- 16 The term "important" will not be defined in the report
- 17 Replaced references to a "dataset" with "data compilation"
- 18 Added parenthetical information about potential routes of exposure specific to early stages of human development
- 18 Added sentence on increasing importance of electronic medical records

# Discussion of Proposed Changes to Section IV (Recommendations)

Members discussed and agreed upon changes to the work group's recommendations, as follows:

<b>Recommendation</b>	Decision
1	REACH is the appropriate model to mention
2	Additional focus on occupational health accepted
3	No change
4	4(c) added to address state-based occupational health surveillance
5	Edited to identify relevant NGOs as strong supporters of Environmental Public Health Tracking, and not to propose that such NGOs lobby Congress
6	Added a sentence noting that national data collection efforts should be relevant to state and tribal governments
7	No change

May edit language related to the specificity of potential actor

Balbus noted that additional changes to the language of recommendations may be necessary before the final version is submitted to the *National Conversation* Leadership Council.

The work group leadership team will keep members abreast of any additional changes to report language and will distribute the final version of the report for member sign-on.
